## What is this Product?

### Type:

This product is a UCITS Fund.

### Term:

This product is not subject to any fixed term.

### Objectives:

The investment objective is to outperform its Benchmark, the MSCI World SMID Cap (Total Return) Index (the "Benchmark"). The Fund will seek to invest at least 60% of its assets in high quality, well managed Small and MidCap companies quoted in global markets with market capitalisation not exceeding that of the largest unadjusted market capitalisation of any of the constituents of the Benchmark at the time of initial investment. Up to 40% of the Fund's assets may be invested worldwide in large cap companies identified through the same investment selection strategy used to identify small and midcap companies for investment, money market instruments, deposits and cash. The Fund will seek to create a concentrated portfolio of approximately 30 reasonably valued, high-quality companies. A proprietary bottom-up methodology for stock selection is used focusing on individual companies rather than the broader market. No unquoted investments are permitted.

The Fund is actively managed and does not track the MSCI World SMID Cap (Total Return) Index. The Benchmark is used for comparison purposes. The Fund may invest in securities not included in the Benchmark. The Fund is monitored, but is not constrained, in reference to the Benchmark.

The Fund promotes, among other characteristics, environmental and social characteristics through the application of ethical exclusions, quantitative and qualitative assessments and engagement with the Fund's investee companies, as further described in the prospectus.

This share class does not pay dividends. Income from investments is included in the value of the units.

### Intended Investor:

The Fund is intended for institutional and retail investors with a basic knowledge of financial products. Prospective investors should be prepared to risk their capital up to the amount invested. This Fund should be held as part of a diversified portfolio of investments.

The net asset value per share is available on Bloomberg and at the registered office of the Company.

Depository: The Fund's assets are held through its depository which is The Bank of New York Mellon SA/NV, Dublin Branch and are segregated from the assets of other sub-funds of Montanaro Smaller Companies plc.

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Company is incorporated in Ireland as an umbrella fund with segregated liability between its sub-funds.

The assets of the Fund are segregated from the assets of the Manufacturer, the Manager and the Depositary and therefore your request to be paid out is not impacted by any default event of the Manufacturer, the Manager, or the Depositary.

There is no compensation or guarantee scheme in place which may offset any loss.

Lack of a compensation or guarantee scheme is offset by the absence of default risk due to the segregated nature of the assets.

## What are the Costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods:

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Note: Management fees on this class are fully waived until 1st January 2025. The investment manager will apply a voluntary waiver of its management fee to cap the ongoing charge figure for this product at 0.70%. ## How long should I hold it and can I take my money out early?

**Recommended minimum holding period: 5 Years**

The Fund is designed to be held over the long term and we recommend that you hold this investment for at least 5 years.

You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (except Irish and UK bank holidays, as set out in the Fund's prospectus).

If you cash in at an early stage this will increase the risk of lower investment returns or a loss.
