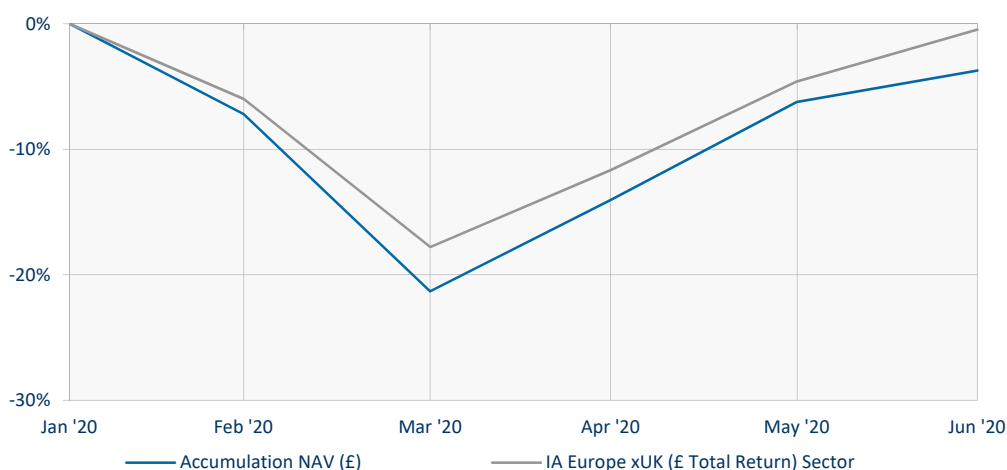

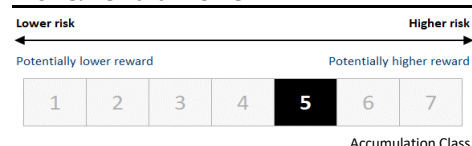

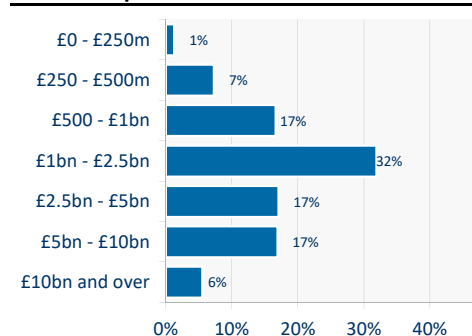

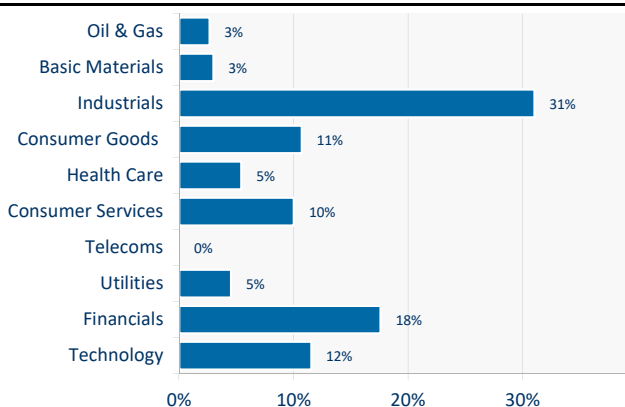

Market Capitalisation Allocation*



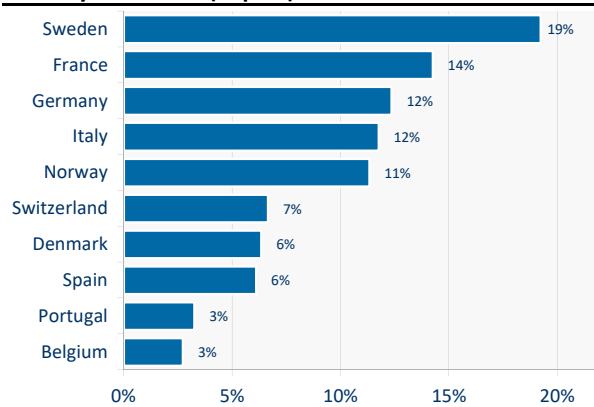
