The Fund may also invest up to 40% in larger sized companies.

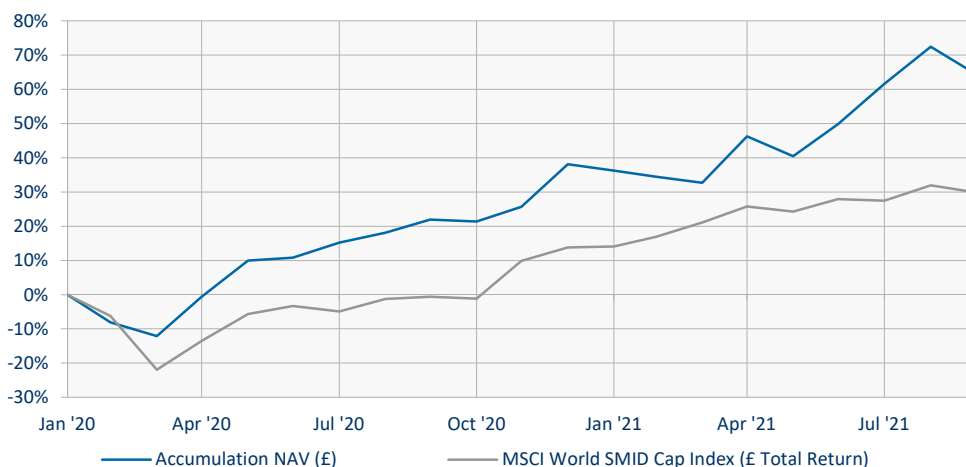

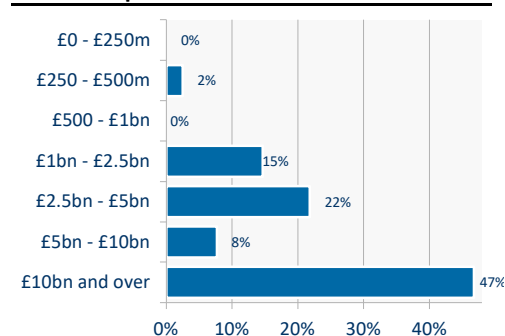

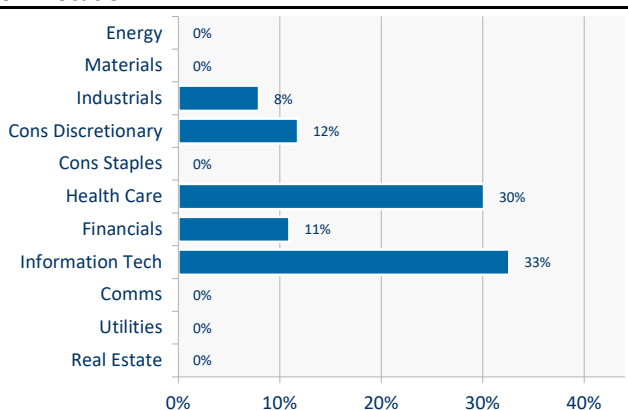

**Market Capitalisation Allocation\***



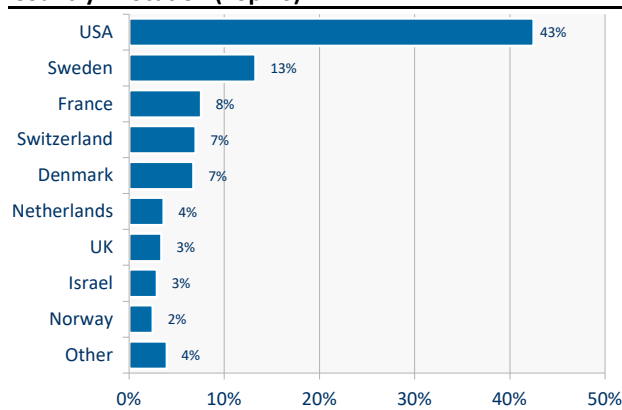
