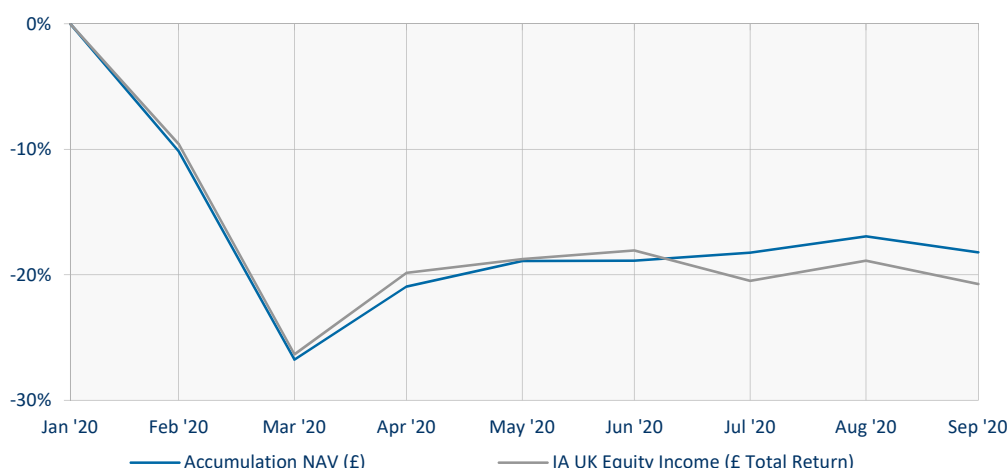

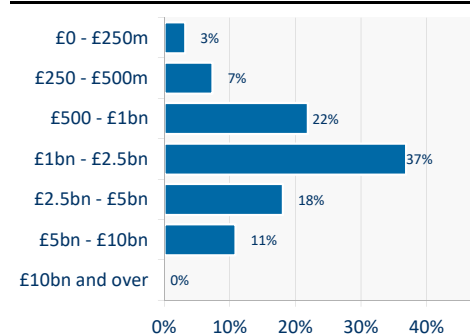

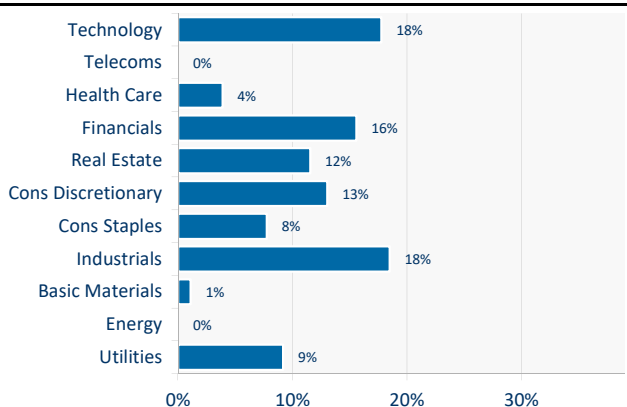

**Market Capitalisation Allocation\***



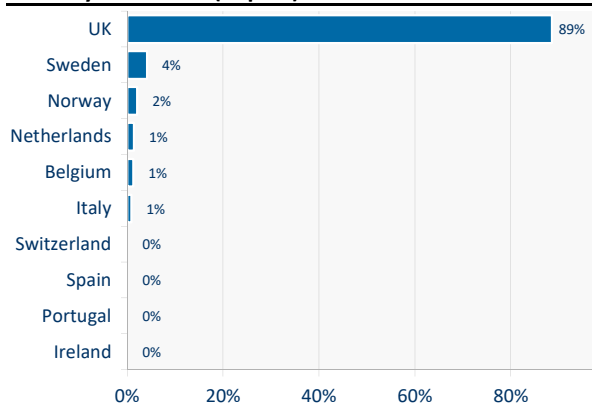
