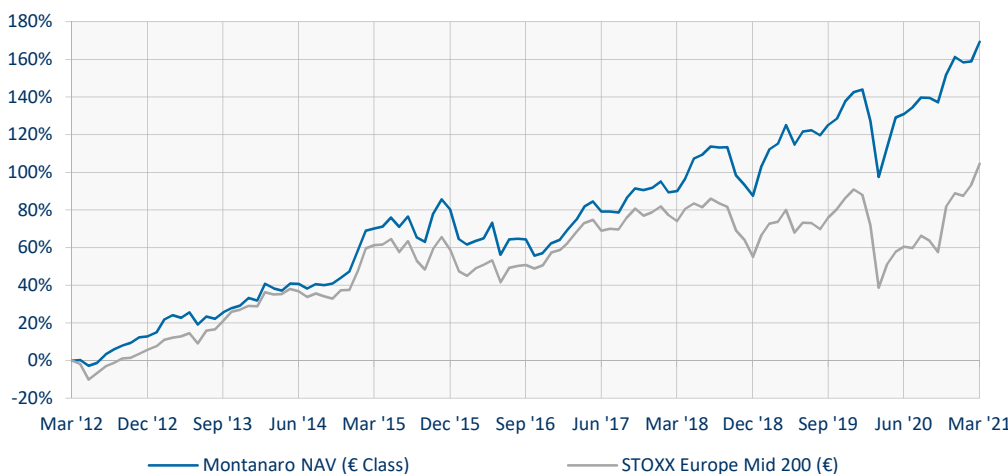

Cumulative Performance Since Inception

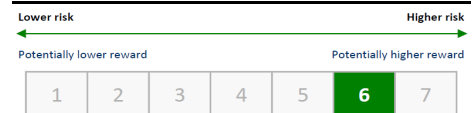

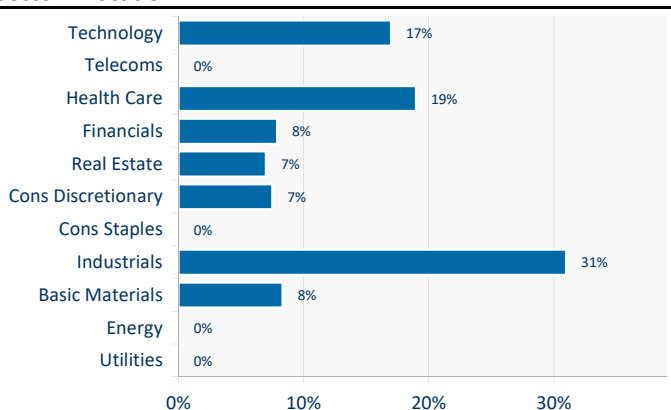

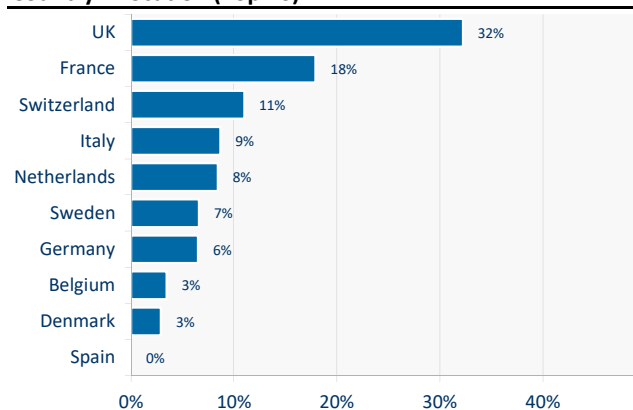
