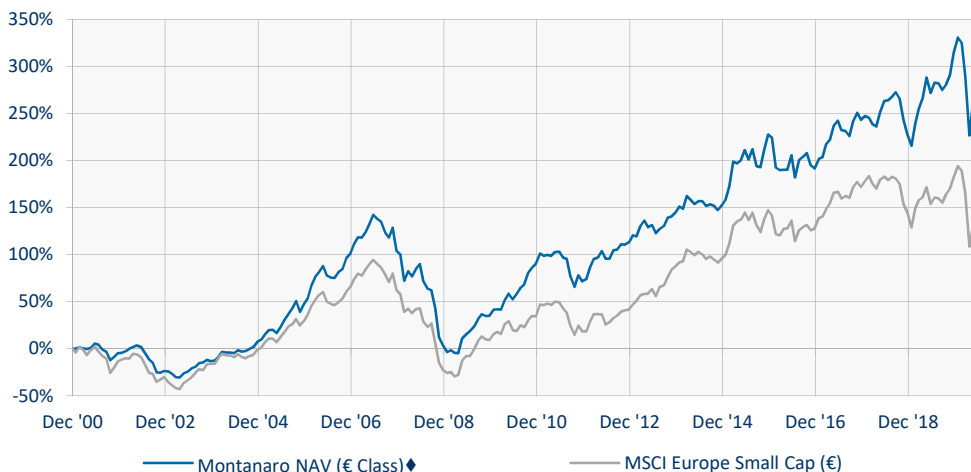

Cumulative Performance Since Inception



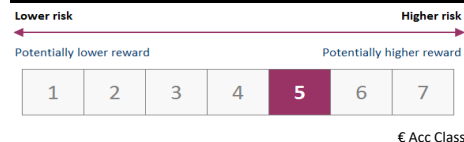

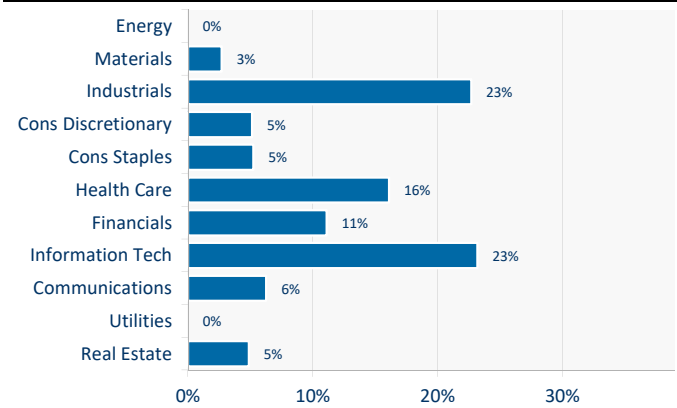

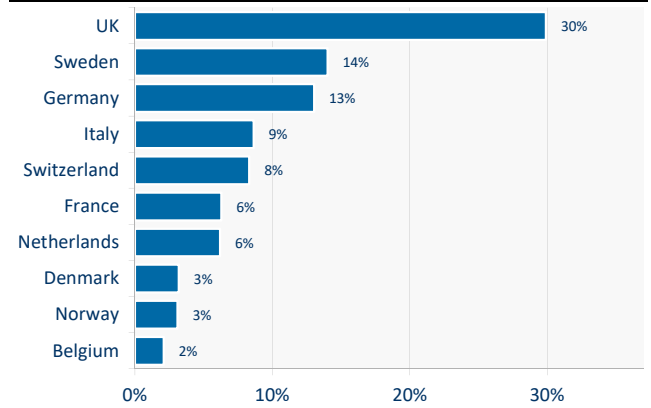
