Objectif du Fonds

Surperformer son indice de référence, le MSCI Europe SmallCap (Capital Return) Index. 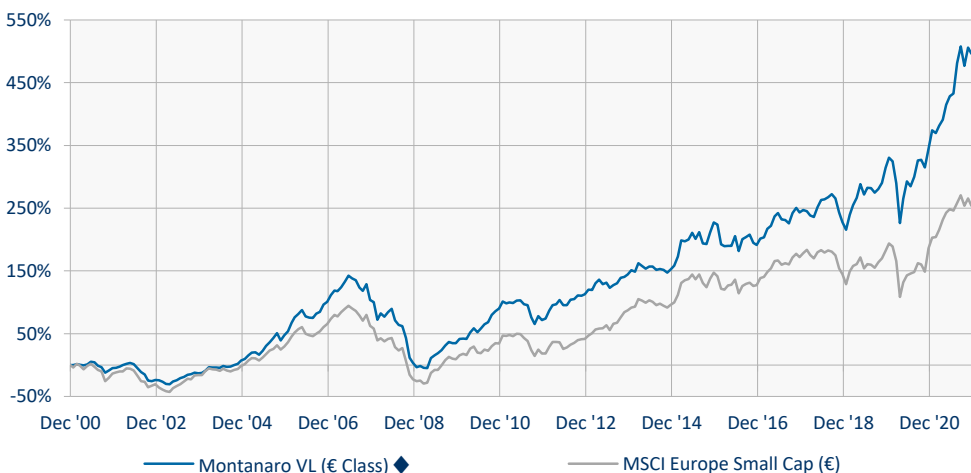

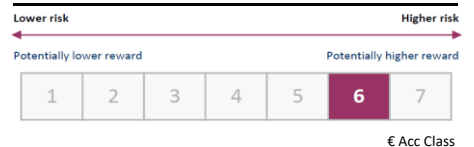

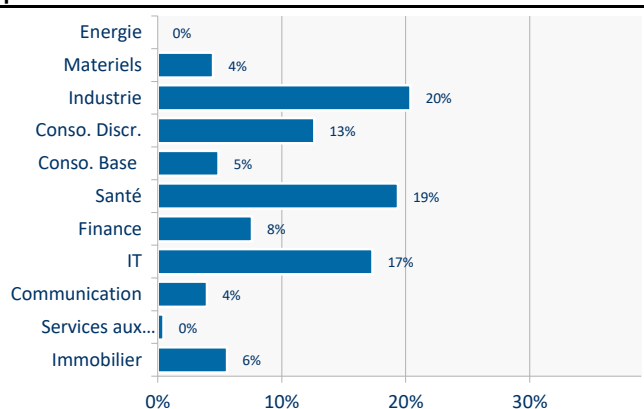

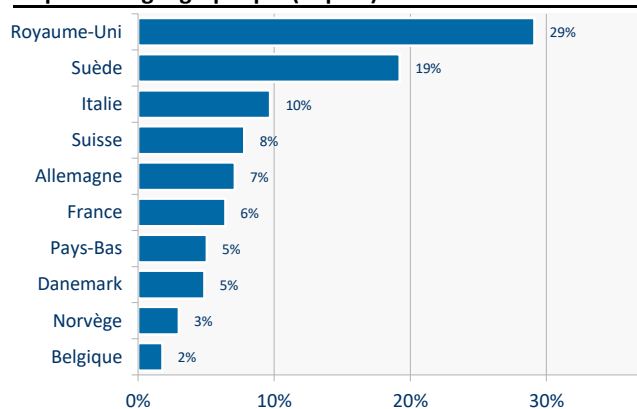
