Objectif du Fonds

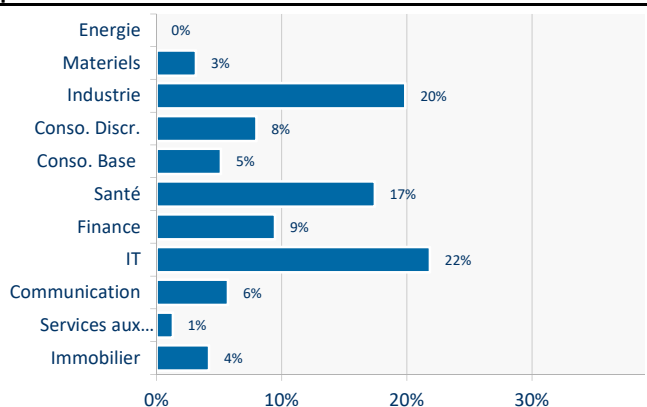

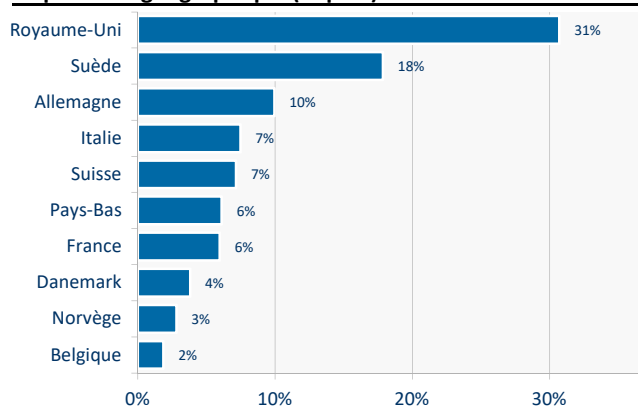
