Fund Objective

No unquoted investments are permitted.

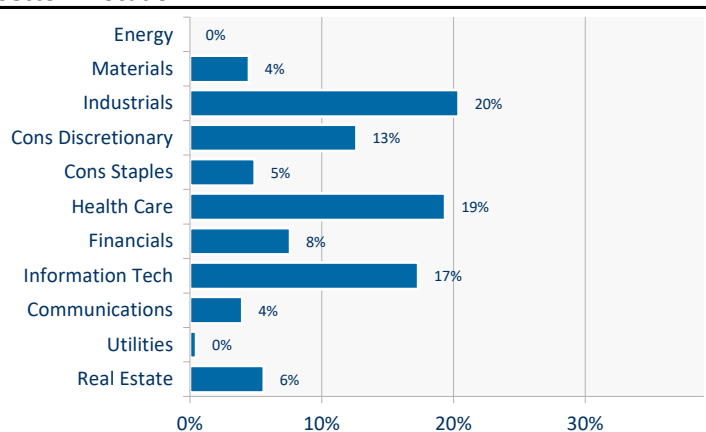

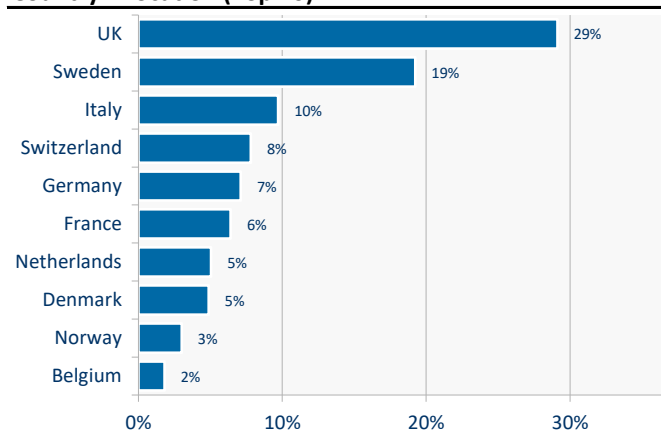
