Fund Objective

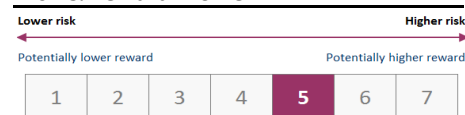

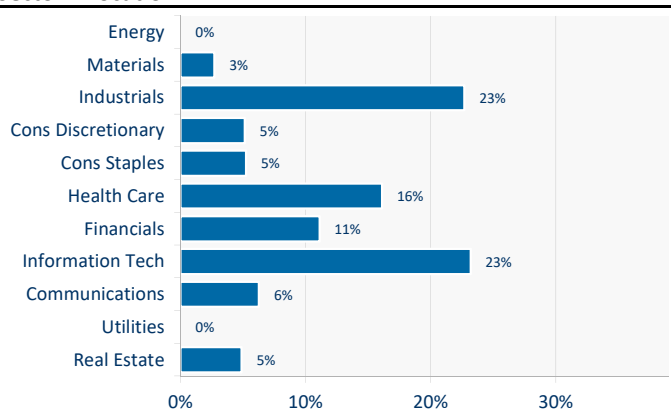

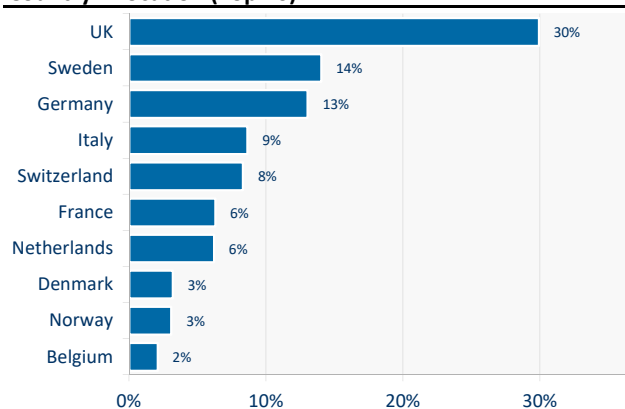
