## Key Investor Information

### Montanaro Global Select Fund (the "Fund")

Share Class: Sterling Accumulation B Class (ISIN IE0007HW6LU0) a Sub-Fund of Montanaro Smaller Companies plc (the "Company"). The Fund is managed by Waystone Management Company (IE) Limited (the "Manager").

## Objectives and Investment Policy

### Investment Objective

To outperform its Benchmark, the MSCI World SMID Cap (Total Return) Index (the "Benchmark").

### Investment Policy

The Fund will seek to invest at least 60% of its assets in high quality, well managed Small and MidCap companies quoted in global markets with market capitalisation not exceeding that of the largest unadjusted market capitalisation of any of the constituents of the Benchmark at the time of initial investment. Up to 40% of the Fund's assets may be invested worldwide in Large Cap companies identified through the same investment selection strategy used to identify Small and MidCap companies for investment, deposits and cash. The Fund will seek to create a concentrated portfolio of approximately 30 reasonably valued, high-quality companies. A proprietary bottom-up methodology for stock selection is used focusing on individual companies rather than the broader market. No unquoted investments are permitted.

The Fund is actively managed and does not track the MSCI World SMID Cap (Total Return) Index. The Benchmark is used for comparison purposes. The Fund may invest in securities not included in the Benchmark. The Fund is monitored, but is not constrained, in reference to the Benchmark.

The Fund promotes, among other characteristics, environmental and social characteristics through the application of ethical exclusions, quantitative and qualitative assessments and engagement with the Fund's investee companies, as further described in the prospectus.

### Income

This share class does not pay dividends. Income from investments is included in the value of the units.

### Fund Currency

The base currency of the Fund is Euro.

### Investment Horizon

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within five years.

### Dealing Frequency

You may redeem your shares, or invest in the Fund, before 12 noon (Dublin time) on any business day except Irish or UK bank holidays.

### Why is this Fund in this category?

The Fund invests in securities which are subject to market fluctuations. The Fund's investments are in multiple regions and may be sensitive to localised economic, market, political or regulatory events.

### Additional Risks

#### Liquidity / Market Capitalisation Risk

Small and MidCap companies may be less liquid than the shares of larger companies and can be more sensitive to economic and other factors. As a result, the Fund may experience greater volatility both in the value of its investments and in its net asset value per share.

### Counterparty / Operation Risk

A counterparty may fail to pay the proceeds related to the sale of securities by the Fund, or may fail to deliver securities purchased by the Fund. Failures or delays in operational processes may negatively affect the Fund.

### Market Risk

The value of investments and, consequently, the price of shares can go down as well as up and an investor may not get back the amount originally invested.

### Exchange Rate Risk

The Fund invests in quoted companies which may have share prices denominated in currencies other than the Euro and may therefore be exposed to exchange rate risks. In addition, holders of a share class in a currency that is different from the base currency of the Fund will be exposed to the exchange rate risk between the two currencies since there is no currency hedging. Different share classes may receive different investment returns.

### Tax Risk

Any change in the Fund's tax status or in taxation legislation could affect the value of the investments held by the Fund.

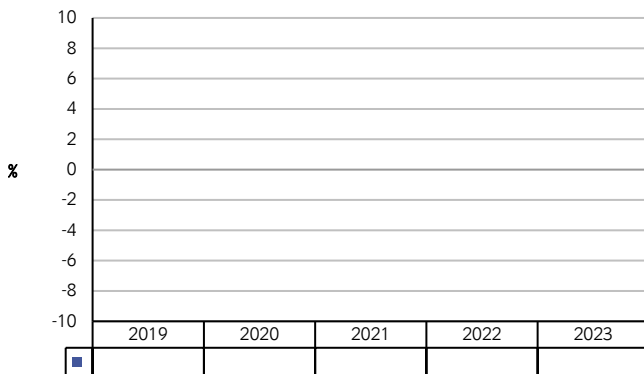
