Fund Objective

To outperform its Benchmark, the MSCI World SMID Cap (Total Return) Index (the "Benchmark"). The Fund will seek to invest at least 60% of its assets in high quality, well-managed small and midcap companies, including Real Estate Investment Trusts ("REITs"), incorporated or domiciled in Australia, Australia, Belgium, Canada, Denmark, Finland, France, Germany, Greece, Hong Kong, Iceland, Ireland, Israel, Italy, Japan, Luxembourg, Malta, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, Taiwan, United Kingdom and United States, listed or traded on an exchange in the aforementioned countries and whose market capitalisation does not exceed that of the largest unadjusted market capitalisation of any of the constituents of the Benchmark at the time of initial investment.

The Fund will be actively managed with a medium term (five years) investment horizon, utilising a bottom-up investment philosophy and a low turnover, buy and hold strategy. The Fund will seek to create a concentrated portfolio of approximately 30 reasonably valued, high-quality companies.






